Country Lake Farm Swim & Tennis Association Swimming Pool Rules and Regulations

1) HOURS OF OPERATION: 9:00 A.M to 9:00 P.M., every day during the season.

2) POOL SAFETY REGULATIONS:

- a) There are NO lifeguards on duty.
- b) Children under the age of sixteen (16) must be accompanied by a parent or guardian over the age of eighteen (18).
- c) Parents or guardians must remain in the pool area for supervision. Baby sitters who accompany children to the pool/tennis area are the responsibility of the members who have hired their services. These members are to ensure that pool rules and regulations are understood and followed.
- d) Pool furniture shall not be placed in the pool or used in any manner not intended (i.e.: using pool chairs to climb on or jump from).
- e) No glass objects (except eyeglasses and sunglasses) shall be taken into the pool areas. Beverages and food are not to be taken into the water.
 However, beverages and food are permitted on the deck areas when in paper, plastic, or metal containers.
- f) For the safety and courtesy of all members, NO PETS (except registered service animals) of any kind are allowed in the pool enclosure without prior authorization.
- g) Persons taking certain medications, suffering from nausea, diarrhea, or communicable diseases, or having open wounds shall not use the pool. Persons should check with their physician to determine if it is safe for them to swim.

3) GUEST & PARTY POLICY:

- a) The guest policy is designed to protect the integrity of the membership by restricting non-member access to the pool facilities. The policy is also designed to allow the use of the pool facilities for entertainment of members' guests. The sponsoring member shall be responsible for the conduct of their guests.
- b) More than 3 guests are only allowed when accompanied by an adult

member of eighteen (18) or older.

- c) Country Lake Farm residents who are NOT paying members of the Swim and Tennis Association ARE NOT allowed as guests of paying members. (*All* residents have the option of becoming members and residents who choose not to pay the membership fees shall not be entitled to the benefits of membership).
- d) Any paying member allowing a non-paying Country Lake Farm resident into the pool facility is subject to termination of membership and privileges with no refund of membership fees.
- e) No private parties shall be allowed at the pool facilities which would deny the members' rights to use the pool or facilities. If you wish to have a party, contact the Board of Directors for approval at least one week prior to your event.
- f) The host of any party will be required to ensure that the facility is clean and undamaged upon completion of the use of the facility. In the event of accidental damage, notify a Board member promptly so they can address the situation.

4) GENERAL POOL RULES:

- a) Alcohol is prohibited on CLFSTA property.
- b) Smoking is prohibited in the Pool area.
- c) Each member must have their key any time they are at the pool.
 Otherwise, members shall be asked to leave the area. There will be a \$5.00 fee for replacement of lost or damaged keys.
- d) Bicycles, roller skates, roller blades, scooters, and skateboards are prohibited inside the pool area.
- e) Running, horseplay, profanity, and abusive language are prohibited inside the pool area.
- f) The last member to leave the pool area shall be responsible for ensuring that the facilities are locked.
- g) No disposable diapers are allowed in the pool.
- h) All members and guests shall use proper trash containers and keep the pool/tennis area free from litter.
